preventive medicines and public health facilities, prevention and treatment of epidemics, viruls or contagious diseases, provision of medical counselling, physiotheraphy, rehabilitation, family planning and welfare facilities and the like.

- (e) To establish, run, management, maintain and/or support medical schools and colleges and institutes for the propagation and advancement of studies in medical science including allopathy, homeopathy, ayurvedic, yunani or any other system.

Managing Trustee is appointed in his place. Subject to general control and supervision of the Trustees, the Managing Trustees shall manage the Trust and its properties and funds and carry on the affairs of the Trust and shall have all necessary powers and authorities for that purpose.

The Managing Trustee shall be the Chairman of the Board of Trustees. In the absence of the Chairman, at any meeting, the Trustees who may be present at the meeting shall elect a Chairman of the meeting. All questions relating to the affairs of the Trust shall be decided by a majority of votes of the Trustees present and voting for the timebeing. A resolution in writing circulated amongst the members of the Trust and approved by a majority of the Trustees for the time being shall be as valid and effectual as if it had been passed at a meeting of the Trustees duly called and convened. Neither shall the Purchaser or Purchasers, transferee or transferees be concerned to see to the application of the purchase moneys or other consideration, or be answerable for the loss, misapplication or non-application thereof.

The receipt signed by any two or more of the Trustees for any income of the Trust Fund or for any documents of title or securities, papers or other documents or for any other moneys paid, given or transferred to them shall be sufficient and shall effectually discharge the person or persons paying or giving or transferring the same from being bound to see to the application or being answerable for the loss, mis-application or non-application thereof PROVIDED ALWAYS that notwithstanding anything herein contained to the contrary any bank account of the Trust may be operated upon by any one or more of the Trustees as maybe authorised by the Board of Trustees from time to time.
